

In just 150 pages, the authors provide a direct explanation of ERM with chapters that include: The definition of ERM, Strategy of ERM, Democratization of ERM, Implementation, Human Resource Elements, Finance, Marketing requirements, Black Swan Considerations. The authors finish with a practical case study involving a software company and the appendix includes templates for heat maps, risk categories, likelihood and impacts scale, sample risk ID questionnaire and more. The authors break ERM down in a relatively simple fashion and using the example of guessing how many jelly beans in a jar, the more participation, the more likely to be projecting the answer. Not the end all, but a good beginning.

I've read "too-many" books on ERM. I believed at the time that I read this book, and remain convinced today, that "Straight to the Point" was/is the best of the bunch. The content is clearly and succinctly presented. A complex subject is made as simple as it can be. The steps to implement an ERM framework are well-explained. His examples provide a basis for extending the model to cover

large and structurally-complex organizations. I have recommended the book to many colleagues. To date, all have praised the book in a similar fashion. Al has done an outstanding job.

This book on Enterprise Risk Management provides a clear working framework for understanding how to put together a program from a practical standpoint. I found this to be a practical guide for establishing an enterprise risk management function particularly for smaller organizations.
